

# **LIMITED LIFETIME WARRANTY**

*Non-prorated and transferable*

**MINNKOTA WINDOWS** warrants to the original purchaser of the Minnkota Windows vinyl window or patio door (warranty is transferable one time only) that the main frame will be free from defects in material and workmanship for as long as you own and reside in the home in which the windows or patio doors were installed.

## **BASIC WINDOW UNIT LIFETIME WARRANTY**

The rigid vinyl in the window is warranted against chipping, cracking, peeling or blistering, for as long as you own and reside in the dwelling in which these windows were installed. This limited warranty does not apply to improper installation, any damage caused by improper handling or storage, flood, explosion, misuse, abuse, vandalism, use of harmful chemicals, unapproved coatings, or other external forces. All warranty work includes replacement parts.<sup>1</sup>

## **COLOR**

Atmospheric pollution and residues deposited on the window can discolor it. Mild soaps or detergents are usually all that are necessary to restore the color. Paint coatings applied by a certified applicator to Minnkota Windows may be warranted by the applicator and or paint manufacturer as stated in the enclosed manufacturer's warranty.

## **HARDWARE**

Balances, cranks, hinges and locking mechanisms used on all windows are warranted for a period of ten (10) years. This warranty does not apply to damage caused by improper handling, misuse, abuse, vandalism, use of harmful chemicals or other external forces.

## **INSULATED GLASS UNITS**

The sealed insulated glass unit is warranted against defects resulting in material obstruction of vision from film formation caused by dust or moisture in the dead air space of the sealed unit for a period of twenty (20) years from the date of purchase.<sup>1</sup> This warranty does not apply to any exterior damage or scratches found after the windows have been delivered or installed.

## **CONDENSATION**

Condensation of any window occurs when warm moist air comes in contact with the cooler surface of a window. Condensation does not indicate a defective or faulty window and is not covered under this warranty. Additional information concerning condensation is available upon request.

## **LABOR**

Labor and freight will be included for a period of twenty (20) years for all insulated glass warranty work and ten (10) years for all hardware warranty work in any Minnkota Windows product. <sup>1</sup>

**THE SOLE AND EXCLUSIVE REMEDY FOR BREACH OF ANY EXPRESS OR IMPLIED WARRANTY OF THIS PRODUCT IS REPAIR OR REPLACEMENT OF THE PRODUCT AT MINNKOTA WINDOWS DISCRETION. WARRANTOR SHALL NOT BE LIABLE UNDER ANY CIRCUMSTANCES FOR ANY INCIDENTAL, CONSEQUENTIAL OR OTHER DAMAGES, TO THE EXTENT THAT SUCH LIABILITY MAY BE EXCLUDED UNDER APPLICABLE LAW.** Some states do not allow the exclusion of limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you. No person, including any agent, employee or representative of the Warrantor has any authority to bind Warrantor to any affirmation, representation, or warranty concerning this product, except as stated in this warranty. This warranty gives you specific legal rights, and you may also have other rights which vary from state to state.

*In order for this warranty to be valid, it must be completed and returned to Minnkota Windows within ninety (90) days of receipt of product. If not returned within ninety (90) days, warranty will be void.*

*Any warranty claims shall be submitted through an authorized Minnkota Windows dealer.*

<sup>1</sup>*Applications other than for single family residential homes are warranted for a period of ten (10) years for materials only. Labor and shipping costs are not included in this warranty.*

# **LIMITED EXTERIOR COATED FINISH WARRANTY**

*Non-prorated and transferable*

The specialized exterior paint coating applied to vinyl products by Minnkota Windows authorized applicators is guaranteed under normal conditions for a period of fifteen (15) years from the initial date of application, against weathering, specifically "peeling, cracking or blistering from/on the applied surface and significant ultraviolet discoloration" (greater than 6 Delta E units) caused by natural environmental atmospheric conditions. Any product failures due to defective paint or improper application will be evaluated and concluded to determine if any application failures are evident. Minnkota Windows will repair any failed product in-the-field or replace the failed product at Minnkota Windows expense for a period of fifteen(15) years from the initial order date.

In the event applicable law imposes any implied warranties, the implied warranty is limited to fifteen(15) years from date of purchase. Some jurisdictions do not allow such limitations on duration of an implied warranty, so the above limitation may not apply to Customer.

This Limited Warranty is void if failure of the applied finish has resulted from accident, abuse, mis-use or improper handling of product, chemical interaction (Stucco leach, acidic washes, hard tack tapes, blowing sand, etc.) or acts of God. Any application of an additional paint or exterior application without the authorization of Minnkota Windows will void the warranty. Any replacement of application service will be warranted for the remainder of the original warranty period of fifteen (15) years, whichever is longer.

The Warranty expressed herein constitutes the buyer's sole remedy whether arising in contract, tort, products liability or otherwise and is in lieu of all other warranties, expressed or implied, including the implied warranties of merchantability or fitness for a particular purpose.
